6. Describe the monitoring route briefly (also draw on map): Since Mary Alice managed to leave the gps unit in her car, the map only shows directional arrows. We walked

from the Lockwood's to the NE corner (pond);

along the north line (first bordering Campbell then the town's Roaring Brook Conservation Area):

along the west line which is also the old M-M trail:

back along the trail that is very near the actual boundary along Lancaster Pike Road.

We then walked north on the trail (rather than the washed-out discontinued road/boundary);

turned up the knoll trail and enjoyed Mary's wonderful bench at the top (photos); back down the knoll trail and down to the Lockwood's house.

Loop and knoll trail completed this past year. Donald H. Bates bench placed at the top of the knoll.

The present trail markings are quite bright - too bright? Group felt they were fine and would fade a bit over time. (And late afternoon walk confirmed that bright is OK.)

New bog bridges on the trail leading from Shutesbury Road are a great improvement. Thanks to the Leverett Trails Committee and RGT for paying for the lumber.

One more trail through Campbell land to the knoll was planned. It was for dogwalking neighbors and never to be put on the map. However, it is very steep at the north end. On Kathy's recommendation, we decided to delay for a year and re-assess whether it is necessary.

Extending the trail east along Lancaster Pike? Interesting idea - this old public road (county road, never discontinued) is less eroded once it gets to the top of the hill.

ATV use. While not causing erosion problems at the moment, RGT Board needs to include this property in its discussion of an overall "motorized vehicle" policy. Final policy/practice needs to be discussed by Bates Property Committee (board members and neighbors)

Boundary marking: still visible (north boundary is only one that is not easy to find) It will need to be repainted in a few years. Having the photographs of the many corner posts was helpful.


Bring map, photographs of boundary corners, and gps with Bates shapefile. Enjoy this lovely property (but expect to get wet feet along the north line).
