no changes in land seen, Pete Kosloski was repairing culvert on Rat Hollow Rd. and working on woods road. Pete is worried about off-road vehicles on power line. We did not see damage, but in the morning we did not walk the power line, only crossed it at north and south line. None of the small, woods roads we crossed in the NE and SW showed unusual wear. In the afternoon, we walked full length of Rat Hollow Road (no unusual wear seen) and some distance north and south of Rat Hollow on power line (worn but not noticeably more than in the past.)

In the afternoon, Pete also expressed concern about Smith right-of-way to the east of property (north of Rat Hollow). Although we have walked the north end each time, have not walked entire distance (which is also a paved driveway). Should do that in the future.

Pete is still planning to put fence west of his boundary with Smith. He has letter giving him permission and is, as permitted, cutting firewood and repairing road culverts.
