Counter clockwise from Boat Ramp along Friendship Trail west and north. South near line on old woods road and then along Woodard Trail to Depot Road and then east along Depot Road.

We found posts in the stream (SE corner of D&M Field), in the wetland (Woodard NE corner) by the pond (NE corner C&E Field), along the trail (C&E Field NW corner), along Cider Mill Road (D&M Field NW corner - not pin, only yellow plastic stake), by the Woodard Trail (NW corner Woodard), and in the dry stream (SE Woodard Corner). We did not think to look for the iron pipe in the Depot Road stone wall (NW Woodard corner).

8. Describe any natural alternations:

some trees down (as there are every year), but nothing dramatic noticed

9. If CR, describe any interactions with landowner(s) during the monitoring or since the past monitoring:

In September 2013, Olivia Bernard requested permission from RGT and the ConCom to do the same view-cutting (cutting the tops off fast-growing shrubs) that she has done every few years. As in the past, RGT said that the cutting does not damage the conservation value of the land - indeed enhances it because dense shrubby areas are excellent (and rare) habitat for birds and other critters. She received permission and the cutting was done.

Bring orange ribbon to re-mark the corner posts.


