Walked both the Friendship and Woodard Trails

In consultation with the Leverett Trails Committee (Mary Alice Wilson) it was decided to discontinue the Woodard Trail because of lack of use. Two signs to trial have been taken down. The sign indicating the "Philip and Katherine Conservation Area" on Depot Rd has been left up.

A fallen tree across north entrance of FT (off of Cider Mill Rd.) will be left as is to prevent bikes from using trail. Bikes erode the trail and expose tree roots. A cut has been made in the truck to facilitate walkers passing over it. Another tree mid-trail has been felled by beavers and serves as a demonstration of their work. This, too, should remain in place.

5. Action Items requiring attention:

A blue plastic 55 gal. drum lies near the shore at mid-trail and should be removed. A submerged canoe is embedded in the shore weeds near the beaver tree and will be very difficult to remove. Let it rest in peace since it is hardly visible. The most south westerly wooden plank bridge is badly sagging and needs replacement. While it doesn't seem to pose a danger since it passes over a shallow ephemeral stream it needs to be rebuilt. The LTC has been advised of this as has Olivia Bernard's landscaper who in the past has constructed the bridge.


