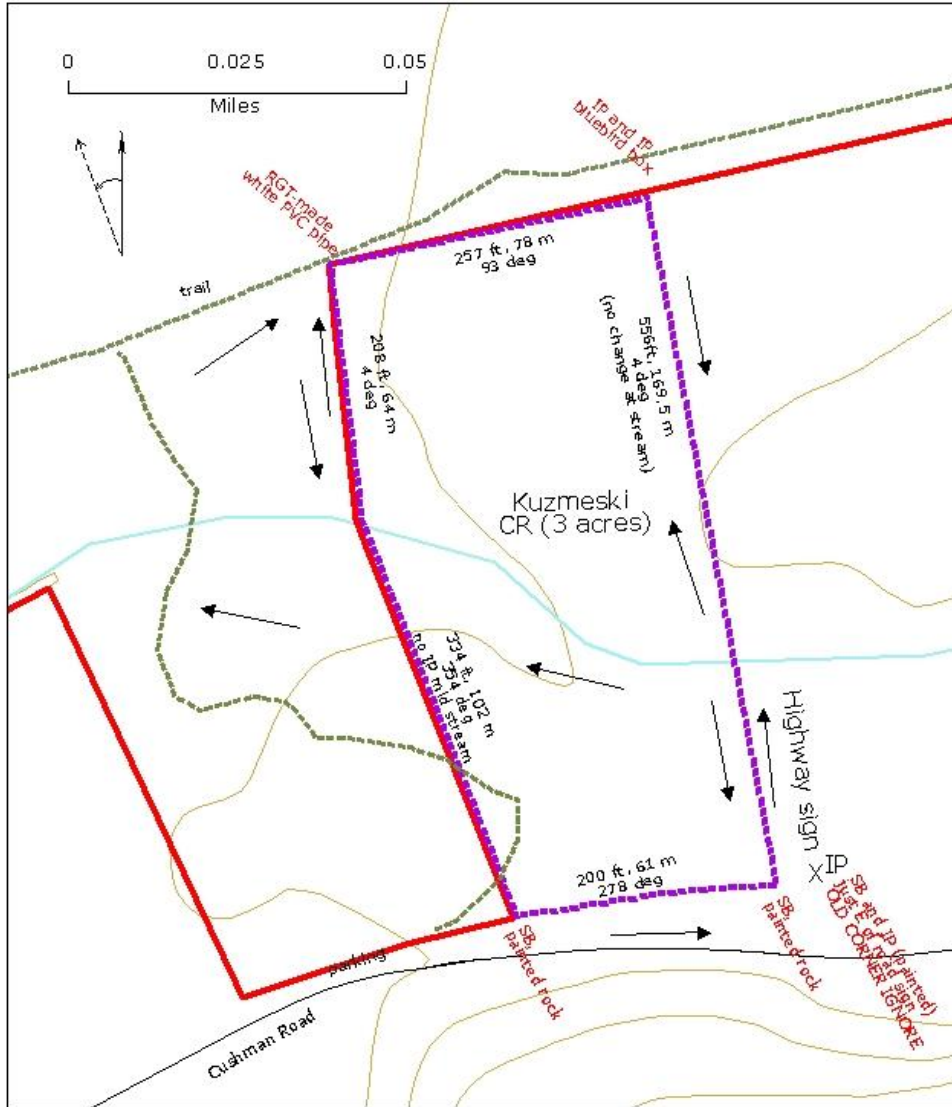

Brief description of route taken (also draw on map): We walked the east line to Roaring Brook, then west through the property to the East Leverett Meadow bridge. We did the rest of the east area and then walked the west line. We tied new marking tape along both lines. Those areas in the woods will also be painted. Each year we say how important it is to mark the corner stones. especially along the road. This year, we caught ourselves by starting at an old corner stone on the neighbor's property. We returned on November 3 rd to re-mark the western line.
