We started by exploring the NE corner, marked by a wood post with birdhouse. After exploring the east boundary, we walked west along the northern boundary. We did not find the southwest boundary marker. We proceeded along the western boundary, then over to the ELM access trail and across the Roaring Brook bridge, and then out to Cushman Rd along the ELM trail. The ELM trail cuts into the Kuzmeski property on the Northwest corner. Then, we proceeded along the southern boundary on Cushman Road. We explored the eastern boundary near Cushman Road..
