No written report submitted 2013. Glen Ayers discussed his visit briefly at RGT meeting - all fine. East line (boundary with Kosloski) he repainted yellow. North and west line (Cowls) need to be repainted - Cowls red line has not repainted in years. South line (Smith) needs to be repainted (white fading). Shelter fine, very little use, always needs to be checked.

4. Date of this year's monitoring:

Boundary walked July 31, 2014. North and most of east line repainted yellow August 19 (when Smith line being repainted), final small section of east line (Cowls) repainted yellow August 24.

Connie Peterson invited (as AMC monitor of the shelter) but was away. A fall walk with her is planned.

6. Describe the monitoring route briefly (also draw on map):

Walked up former M-M trail/white-dot trail to Rat Hollow Road. Turned north along Smith boundary. Then east following stone wall until in sight of

AMC shelter. Visited shelter then back to Smith (white-painted) line to the stake and stones. Turned north along the yellow-painted Kosloski line (difficult to follow through the mountain laurel) to the stake and stone (Cowls corner). Then west along the Cowls blazes (red paint very faded, but Virginia Rail Fence easy to follow). At the woods road on the Cowls property turned south - the line is just to the east of that road.

7. Describe any man-made alterations (draw on map/take photos. If no, write "no observed"):

AMC shelter and privy in good condition. The journal on the shelf indicated very little use. (On 8/15 while painting the Smith boundary we observed 4 young men packing into the shelter - probably from a car parked on Shutesbury Road.

AMC shelter is in good shape - primarily because it is not often used.

South boundary (Smith) is painted white with a brush and should be fine for a number of years. All other boundaries were spray-painted yellow (east in 2013; north and west in 2014). They will need repainted within a few years.

Always check shelter.

The north Virginia Rail Fence boundary is especially interesting. (stack of stones used as the base for interlocking rail horizontal fence pieces - these fences were easier/quicker to build that stone walls - over the years they were replaced with barbed wire but only if the area was still used as pasture. (There is lots of barbed wire along the east edge of the Smith property especially south of Rat Hollow Road and the first stonewall area.) See photos.




Above: N line, Virginia Rail Fence Stones. Trees blazed by Cowls, but red paint has faded.
