Accessed via Whitney Road through Hugh and Ceann Roberts property. Walked clockwise along boundary from trail (pins G, H, I on monitoring map). There was still a ladder against a tree near I. Assuming it was Hank's, we moved it to one of his fruit trees. We did not go to pins at J, K or A. Walked trail from overlook at Hank's to pin at B, then to location of pin at C. The pin at C, at the end of the ledge was covered by a fallen tree and not visible. Flagging is gone. Went along "principle ledge to location of drill hole at D, but did not find it. Next year, bring photos to help locate. Found pin E then took the blue trail back to Whitney Road.

5. Action Items requiring attention:

- Boundaries should be remarked and pins flagged, but today it was too wet re-paint boundaries.
- Discussion of replacing the bench in process.
- Within the next year, the trees at the base of the hill near Hank Berry's land should be cut to ensure ongoing view to the Peace Pagoda and to Mount Greylock.
