On November 1, Bill and Mary Alice had the opportunity to talk with Bertrand Raymond. He was out mowing and we asked him where the line was (which of course he knew). Had nice general conversation. He suggested that Andy and Alice Scheffey gave (technically sold for \$100) him the small amount of land on the east side of his property because it already had the barn on Scheffey land. And said that Andy had given him right of way which meant he could store things in that right of way. (Probably not technically true – he does have the right of way.) Deed says:

....the right to pass and repass, with or without vehicles over that portion of said old woods road which abuts thereinbefore described parcel of land for all purposes for which said ways are generally used. (Book 01639, p. 60, 1980 same day as Lashway land sold to Raymonds)

Clearly this use of the right of way has been going on since 1980 (and probably earlier). And RGT would not want to change it. However, annual monitoring should include walking the western line and noting any significant changes. RGT would want to be involved should the property be sold.

As an aside, Mr. Raymond said he had been interested in buying the land next door (now RGT), but Andy said he had "given it to Audubon." When I explained that it was not Audubon but Rattlesnake Gutter Trust, his response was "well, same thing." I said, actually not quite Audubon was a state organization and RGT was local. Probably the best description of the response (although he did not say anything) would be "whatever." We had a very nice discussion about the area, wildlife, and being outside. This is the first time that I know that RGT folks have talked with him – and this time only because he was outside mowing. (Perhaps our choice of cold, snowy fall days for monitoring should be re-thought!)

Because of the discussion with Will Anderson, Mary Alice did a pretty thorough review of the history of the Fitts Lot and the Turner Lot and tried to find as many references to distances as she could. The present map is a great improvement. (The change in the eastern line of the Turner lot is probably buried in the Stetson-Cowl era (1903-1968). NO WAY – and it is not necessary to find out.
