

Some years there has been a concern about parking vehicles in the right-of-way area next to the Raymond's. The number of vehicles has decreased through the years and this year there were none.
After one of the major storms, some cuttings from the many fallen trees were hauled to the back of the woods road next to the Raymond's. That pile has not been added to.
We checked the other short woods roads that lead in from the property and did not find any trash or damage.
There were lots of bottles, cans, styrofoam cups, etc. along the road. (We may not have done the trash pickup last year.) The non-returnables construction-size plastic bag was full and heavy. The possibly returnable smaller white garbage can bag was full.
List any needed follow-up:
The red paint is fading, needs to be repainted next year.
Suggestions for next year's monitoring team?
Trip, with the trash pickup takes two hours. Bring heavy-duty bags and gloves. Walk up all roads/trails from Shutesbury Road to check for trash (these spurs never go far).
And bring red paint (and map, compass, and gps is available).
