During our annual walk, we always have an opportunity to visit with Pete Kosloski and his wife, Sandy Kirley (their wonderful border collies alert them.) It is an opportunity to talk about Leverett issues, and to catch up on any problems. This year, they are getting walkers coming through their land who think they are at the end of neighboring Number 6 Road (and the Cowls kiosk). While Cowls will be asked to put up a directional sign, it is unlikely that they will actually do it. Pete agreed that walkers were better than the jeeps, but he still would prefer privacy. They have not yet built the fence back on the Smith property (which they have written permission to do), but still intend to get that done.

On a different topic, the walk took much longer this year because of the painting. It also reminded us of the grazing history of the property - walking exactly on the line, especially in the west, means walking back and forth over a very extensive, old barbed wire fence.

It was also a pleasure to listen to two former students/colleagues of David's (Matt Kelty and Jimmy Grogan) talk about the evidence of David's forest management decisions as they walked the Conservation Restriction.
