Iron pin that used to be buried in a large juniper bush is now somewhere underneath a pile of rocks (see picture #3).

Owners and Pete Kosloski are concerned about the damage done by increased use of recreational vehicles (jeeps and ATVs). At least one sign has been installed – see photograph #1. (Seen and photographed on second trip to collect trash along Smith/Shutesbury Road line.) There is hope that an impending CR on the Cowls Brushy Mountain property will restrict motorized vehicles throughout this area. It will probably be next year before the CR process is complete.

There is also the possibility of the owner and their forester, Lincoln Fish, putting up signs describing the forestry practices which would be a great addition to the property.

2. At Shutesbury Road, new gate entrance to power line (property owned by Western Mass Electric (or whoever owns the power lines now). Smith sign on the right.




3. The south iron pin on power line somewhere under pile of rocks (juniper barely visible at the edge).
